Dear Incoming Students for Academic Year 2023-24:

## University of California Policies Regarding Immunization Requirements and TB Screening

- All new, incoming undergraduate and graduate students are required to obtain four (4) vaccines (or provide evidence of compliance) and complete a TB Risk Screening Form no later than the 1<sup>st</sup> date of instruction for the term in which the student is entering UCI. Visit here for details. Certain exemptions may be allowed.
- If an incoming student has not complied with these requirements by the deadline date, Student Health Center will place an academic hold (Hold Type "2") on the student's record preventing the student from enrolling in classes for the following term (e.g., holds placed on Winter Quarter/Spring Semester (Law) classes for students who enter UCI in the Fall term).
- The University's COVID-19 vaccination policy and related information can be found <u>here</u>. <u>ALL</u> registered students and continuing education students are required to be <u>vaccinated or affirmatively decline</u> COVID-19 vaccination.
- The University <u>encourages</u> the flu vaccination in AY 2023-24 for <u>ALL</u> incoming students including returning, continuing and continuing education students. Visit <u>here</u> for continuous updates.
- All students, in order to be deemed compliant, must enter their respective immunization dates and upload their immunization record(s) <u>online</u> through the Wellness, Health & Counseling Services <u>Student Health Patient Portal</u>. In addition, incoming students must complete the TB Risk Screening survey on-line.
- For questions regarding TB screening and all other immunizations, please send a secure message to SHC via the <u>Student Health</u> <u>Patient Portal</u>. (Select "Messages" on the left sidebar; click on "New Message"; Select "I would like to send a CLINICAL secure message to SHC"; Select the "New Student Immunization Requirement" message option; Compose and send your message.)

## UC Student Health Insurance Plan (UC SHIP)

- All registered students are automatically assessed the fees associated with the UC Student Health Insurance Plan (UC SHIP). The UC SHIP premiums and fees are included in the total tuition and fees that are assessed/billed to your ZOT account.
- If you would like to "waive out" of UC SHIP because you have other health insurance coverage that meets UC's waiver criteria, then you must submit an online waiver application no later than the published waiver deadline dates on the Waiving SHIP webpage. If the waiver application is approved, then you will receive a credit on your ZOT account for the UC SHIP fees. The credit typically appears within 7-10 business days following waiver approval.
- > The health insurance requirement and the waiver application process apply to all registered students regardless of their mode of instruction or place of residence. Limited exceptions apply to online graduate programs that do not require UC SHIP assessment.
